Publication pursuant to § 26 Abs. 1 WpHG In accordance with § 21 para 1 WpHG Fidelity Investments International, Hildenborough, UK, have informed us retroactively in the name and on behalf of Fidelity Management & Research Company, Boston MA, USA, that on April 28, 2006 Fidelity Management & Research Company exceeded the threshold of 5% of the voting rights in Wincor Nixdorf AG, Paderborn, Germany, and on that date Fidelity Management & Research Company held 5.04% of the voting rights in Wincor Nixdorf AG arising from 833,196 voting rights.
